Externalities Triggered by Systemic Change

- In economics, an externality is the cost or benefit that affects a party who did not choose to incur that cost or benefit.
 - People with health insurance must often select from limited options.
 - Providers must often swim in a pool designed (or polluted) by others.
- Economists often urge governments to adopt policies that "internalize" an externality, so that costs and benefits will affect mainly parties who choose to incur them.
- Independent practitioners faces increasing challenges as consumers face increasing economic pressures in a system with rapidly changing regulations.
 - What will be covered?
 - How much will co-insurance cost?
 - How will lower cost providers affect the marketplace?

Can Independent Practitioners Demonstrate Quality Outcomes

- Integrating outcome assessment in independent practice
 - Keep great records
 - Integrate assessment tools
- Is CBT the "gold standard?" (No, but you'd better be ready.) Leichsenring & Steinert (*JAMA*, September 21, 2017)
 - Variable study quality
 - Weak empirical tests
 - Uncontrolled investigator alliance
 - Central mechanisms of change not corroborated
 - Limited efficacy
 - No clear evidence of superior efficacy

Will Master's – Level Clinicians Own the Marketplace?

- APA and the "master's issue"
- CACREP (Council for Accreditation of Counseling & Related Educational Programs) as a paradigm.
- What's the value added of the doctoral credential?

Why Choose a Niche Area? Walker

- You feel <u>competent</u> to do this work.

- You know referral sources in this area.
- <u>No one else</u> in your community is doing it.
- You can get consultation or supervision when needed.

- Look at the ABPP list of specialties
